Thank you for your interest in the Mortuary Science and Funeral Service (MSFS) program at Southern Illinois University Carbondale. A variety of circumstances, including rules of accreditation, limitations of facilities, and the faculty/student ratio make it necessary to limit enrollment in the program. Students will be admitted to the program in January and will begin the curriculum in August 2009. In order to give each applicant a thorough and fair evaluation, an MSFS application must be completed in addition to the University application procedure. The Mortuary Science and Funeral Service application is enclosed with some other important information. Students are evaluated using criteria that indicate their potential for successful performance in the Mortuary Science and Funeral Service program.

To be considered for admission, you must complete and submit **ALL** requested application materials for evaluation. It is very important that you follow the procedures accurately and complete your MSFS application as soon as possible. Only qualified students with completed applications will be considered. Admission to the Program will be closed when all positions in the class are filled.

## GENERAL PROGRAM INFORMATION

### MORTUARY SCIENCE AND FUNERAL SERVICE Southern Illinois University Carbondale College of Applied Sciences and Arts

#### Facts to consider before applying to the program:

1. Laws governing the funeral service profession are enacted at the state level; therefore, licensure in one state does not guarantee licensure in another state. Prospective applicants should contact the state in which they plan to seek a Funeral Director/Embalmer's license to obtain that state's specific requirements. Graduation from this program does not assure the individual of licensure in all states.
2. Felony convictions may limit an individual's ability to achieve licensure or employment.
3. Any applicant who has a physical disability should contact the state in which they plan to seek licensure to determine if the disability will affect licensure.
4. In accordance with the Americans with Disabilities Act (ADA), prospective students need not demonstrate that they can meet state licensing requirements in order to be admitted to the program.

#### **There are no course prerequisites for this Program. In order to be considered for acceptance into the Mortuary Science and Funeral Service program, prospective students must:**

1. be admitted to SIUC in good standing;
2. have completed the Mortuary Science and Funeral Service program application form;
3. have a licensed Funeral Director/Embalmer complete the reference form verifying that the applicant has observed, volunteered, or worked in a funeral home under his/her direct supervision for a minimum of three funeral services,\*
4. have the appropriate individual submit an education reference form **OR** an employer/character reference form on behalf of the applicant;\*
5. submit typed responses to the biographical information questions;
6. submit the Hepatitis B vaccine verification form showing you have received at least the first shot in the series, and listing the dates of the remaining shots;
7. have at least a 2.0 Grade Point Average;
8. have at least a C average in all transferred courses that may be tested on the National Board Examination;
9. submit official college transcript(s) of all college course work as well as a class schedule of any courses in which the applicant is currently enrolled.

\* References from family members will not be accepted.

Although SIUC Admissions and Records and/or your current academic adviser may have some of the above listed materials, **IT IS THE APPLICANT'S RESPONSIBILITY** to submit additional copies of these materials to the Mortuary Science and Funeral Service office for your program application file. The applicant is also responsible for checking on the completion of his/her application materials.

**Facts to know about the evaluation criteria for admittance:**

- 1 Academic potential as determined by:
  - ACT score
  - Science grades (College and/or High School)
  - High school grades and class rank (if under 26 hours of transferable college credit)
  - College grade point average based on 26 hours of college credit hours
2. Biographical information which addresses professional aptitude; willingness to abide by health regulations and ethics of the funeral profession; knowledge of funeral service; and motivation to achieve educational and career goals.
3. Work/volunteer history
4. References

Based upon the above criteria, each applicant will be assigned an academic numerical value. Completed files will be evaluated beginning in January 2009.

**Notification of Status:**

Starting in January, completed application files will be reviewed by the Selection Committee. **ONLY COMPLETED FILES, INCLUDING ALL THE INFORMATION LISTED ABOVE, WILL BE CONSIDERED.** If you have met the minimum requirements, you will be notified of your acceptance to the program. If you do not meet the minimum requirements, you will be notified immediately of non-acceptance. When maximum enrollment has been reached, additional qualified applicants will be designated as alternates should any of those originally accepted decline the notification of acceptance. All other applicants, and any inquiries thereafter, will be notified that the enrollment is closed. **Faxed and/or photocopied application materials will not be accepted.**

**Facts to know if you are admitted to the Program:**

1. Students must submit proof of completion of the Hepatitis B vaccine or Titre Test.
2. Students will be required to purchase Mortuary Science and Funeral Service program surgical scrubs, an MSFS program lab coat, disposable gloves, and other necessary personal protective equipment.
3. Students will be required to dress in professional clothing once a week and for any field trips, speakers, or special events. Professional dress, as defined by the Program, will include business suits and other such clothing that would be appropriate to wear when conducting a funeral service.
4. Students are required to participate in field trips and speaker presentations. These events may not always fall during scheduled class times but students will be given ample notice to make necessary arrangements.
5. Students will be assigned to an internship location unless other arrangements have been made and approved by the Internship Coordinator and Program Director.

**Mortuary Science and Funeral Service Mission Statement**

6. To prepare students so that upon graduation they may participate in the development and implementation of solutions in the health care area.
7. To provide students with a basic knowledge for compliance of laws at the state and federal levels, as well as with those of other regulatory agencies, pertaining to funeral service practices, public health, and the profession.
8. To prepare future funeral directors/embalmers with a strong background in social sciences, humanities, natural sciences, communication and mortuary sciences who will be able to ethically apply this knowledge in all situations.
9. To provide funeral directors/embalmers to meet the employment needs of southern Illinois, the state of Illinois and the country.
10. To encourage students to continue professional growth through continuing education and research following graduation.

## ESTIMATED EXPENSES FOR MORTUARY SCIENCE AND FUNERAL SERVICE STUDENTS

### Tuition and Fees:

Tuition and fees for the University have been established by the Board of Trustees of Southern Illinois University Carbondale. See the [Southern Illinois University Carbondale Bulletin](#) (Undergraduate Catalog).

### Course Fees are as follows:

MSFS 225a & b, Embalming Theory and Practice	\$100.00
MSFS 245, Restorative Art	150.00
MSFS 302, Color and Cosmetics	50.00

### Room and Board:

Room and board costs are dependent upon the type of housing the student selects. Housing information will be sent to the student upon admittance to the University.

### Textbooks:

The estimated expense of textbooks for courses within the major is approximately \$1,000. This figure does not include the costs of textbooks for University Core and support courses.

### Laboratory Items:

Students are required to purchase Mortuary Science and Funeral Service program surgical scrubs, an MSFS program lab coat, disposable gloves, and other necessary personal protective equipment. These items are available at the University Bookstore on campus and will be utilized in MSFS 225a&b - Embalming Theory and Practice. Cost of these items is approximately \$150.

The student also will be required to purchase a plastic skull, modeling instruments, and modeling restorative wax. These items are also available at the University Bookstore on campus and will be utilized in MSFS 245 – Restorative Art. Cost of these items is approximately \$70.

### National Board Examination:

In accordance with the American Board of Funeral Service Education (ABFSE) accreditation standards, each student will be required to take the National Board Examination prior to graduation. The expense of the Exam is the responsibility of the student. In addition, NBE scores for students from the Mortuary Science and Funeral Service program are available in the Program office. The annual passage rate of first time takers on the National Board Exam (NBE) for the most recent three year period for this institution and all ABFSE accredited funeral service education programs is posed on the ABFSE.

### Internship:

As part of the curriculum, during the senior year each student will be **assigned to an approved off-campus internship facility**. Students will register for MSFS 410, 411 and 412, and will earn college credit for this experience. The internship courses are only offered during the spring semester. All expenses related to these courses (travel, living, etc.) are the responsibility of the student.

Employment as a funeral director/embalmer is dependent upon completion of the degree program in Mortuary Science and Funeral Service, attaining a passing score on the National Board Examination, and filing the appropriate licensure application with the state. The examination and the licensing process result in additional expenses to the student and are determined by the appropriate agencies. These expenses are not affiliated with the Mortuary Science and Funeral Service program but are expenses of all graduates seeking licensure.
